These tree services have been approved by Boise Community Forestry to perform work (pruning, removal, etc.) on trees on the public rights-of-way. To be licensed, each of these companies must employ at least one individual currently certified as an arborist by the International Society of Arboriculture (ISA). ISA Certified Arborist have completed an extensive exam relating to safety and the growth and healthy maintenance of trees. In addition, Boise City arborist examine their work to help assure tree care. Finally, proof of insurance (not less than \$500,000 or the amount currently required by Idaho Code Title 6) against property damage is required prior to licensing.
