All levy funds must be spent solely on the benefits listed above, not administrative costs, and the fund will be subject to review by a citizens' advisory committee and an annual audit. The District has no existing indebtedness. The estimated interest rate anticipated on the proposed bonds is 3.25%. The range of interest rates is 2% to 4%. The total principal to be repaid over the life of the proposed bonds is \$12,000,000; the total interest to be repaid over the life of the proposed bonds is \$4,626,225; the total amount to be repaid over the life of the proposed bonds, principal and interest, based on the anticipated interest rate is estimated to be \$16,626,225.</p>
